History

The Foundation was established in 1982 as a non-profit, 501 (c)(3) corporation under the laws of the State of Idaho. IPTEF is a separate functioning entity organized for the sole purpose of stimulating and promoting quality Professional-Technical Education within the State of Idaho. Recognizing the need for a skilled workforce in the future, the Foundation provides, solicits, receives and administers scholarships, instructional equipment donations and works to provide training opportunities for instructors to keep current with changing technologies within their current fields. The Foundation is self-sustaining and relies entirely on individual and business/industry donations to provide supplemental funding to students and instructional personnel.

Goals

Foundation Goals include:

- Provide scholarships to instructors to update their technical and teaching skills
- Provide scholarships to students to participate in national conferences to demonstrate the skills and knowledge needed for their selected career fields
- Obtain and distribute equipment and donations from business/industry for program improvement
- To collaborate with other educational organizations that help students, teachers and programs
- Supplement programs and activities that are statewide

Why Individuals, Businesses/Industries Should Donate

- 1) The work place is constantly evolving. Training programs must be upgraded so that graduates are prepared for the technological challenges in their chosen career. Financial and equipment donations from industry help schools keep up with the constant changes.
